SPECIAL NEEDS PLAYER FEES

Fees listed for Special Needs Players are applicable only to players registering in a Football NSW approved club or association based program which operates as part of the Football4All state program.

All Special Needs Programs operating within Football NSW must be approved by the local Association and by Football NSW. Approved Special Needs programs are listed on the Football NSW website under Resources.

PLAYER CONTRIBUTION (ACCIDENT SUPPORT PROGRAM)

Player contributions towards the Accident Support Program are based on a Junior and Senior category.
For purpose of the Accident Support Program only,

- a Junior is defined as any player between the age of five (5) or turning five (5) up to and including the age of eighteen (18) or turning eighteen (18) in the year.
- an Adult is any player aged nineteen (19) or above.

❖ **Student and Adult categories no longer apply to the Accident Support Program**

SCHEDULE FOR PAYMENT OF FEES

Status return to be completed and returned by Friday, 8 July 2011.
