### Charge(s) and Determination(s):

Charge(s)	Tribunal determination
<p>1. The Respondent (coach Sydney Olympic) used offensive, insulting or abusive language and/or gestures towards a Match Official) in breach of section 15.4(d), Schedule 3, Table b, Number 1 of the FNSW Grievance and Disciplinary Regulations (<b>Regulations</b>).</p>	<p>1. <u>Plea</u>: Guilty</p> <p>2. <u>Finding</u>: Guilty</p> <p>3. <u>Determination</u>: Suspension of three (3) Fixtures (MMS + 2 Fixtures). Note - one fixture stand down has already occurred.</p> <p>4. <u>Reasons</u>: Whilst the Respondent showed remorse for his actions on the day he did not deny the officials reports (adjusted on the night). The minimum suspension applied due to respondent previous clean record and plea of guilty.</p> <p>5. <u>Suspended from</u>: Coaching, Acting as a Match Official and Acting as a Team/Club Official.</p> <p><b>Notes: The restrictions above include no admittance in or close vicinity to the Technical Area, Sidelines, and Referee's Room.</b></p> <p>Attendance is permitted on training nights and in the Player's Change Rooms on Competition Day.</p> <p>Coaching from the stands is NOT PERMITTED.</p>

The Tribunal determined that the costs of the Tribunal, as determined by FNSW, be met by the Respondent.
