### Charge(s) and Determination(s):

<b>Charge(s)</b>	<b>Tribunal determination</b>
<p>1. The Respondent (Jason Najdovski) used offensive, insulting or abusive language and/or gestures towards or about a Match Official in breach of section 15.4(d), Schedule 3, Table B, Number 1 of the FNSW Grievance and Disciplinary Regulations (<b>Regulations</b>).</p>	<p>1. <u><i>Plea:</i></u> Guilty. <u><i>Finding:</i></u> Guilty</p> <p><u><i>Determination:</i></u> Three (3) fixtures suspension (MMS + 2 Fixtures).</p> <p><u><i>Reasons:</i></u> <i>The GPT found there was sufficient evidence to show that the Respondent did use what may be termed as abusive (but not swearing directed at the Referee / ARs). This decision was arrived at when the AR Christopher Jones confirmed upon questioning (on the telephone) that he believes that the swearing was not directed towards the Officials.</i></p>
<p>2. The Respondent (Jason Najdovski) displayed unsportsmanlike or unprofessional behavior in breach of Section 15.4(d), Schedule 3: Table C, Number 7 of the FNSW Grievance and Disciplinary Regulations (<b>Regulations</b>).</p>	<p>2. <u><i>Plea:</i></u> Guilty. <u><i>Finding:</i></u> Guilty.</p> <p><u><i>Determination:</i></u> Four (4) fixtures suspension.</p> <p><u><i>Reasons:</i></u> <i>The GPT accepted the Respondent's guilty plea having determined that his behaviour was unprofessional.</i></p> <p><i>The Respondent is suspended for three (3) Fixtures for the offence under Charge 1 and four (4) Fixtures for the offence under Charge 2.</i></p>

	<p><i>The GPT applied a discount of two (2) Fixtures due to the Respondent's apology and early guilty plea.</i></p> <p><i>The Respondent is suspended for five (5) Fixtures for the offences from all Football related activities including spectating.</i></p>
<p><b>Costs:</b></p> <p>The Tribunal determined that the costs of the Tribunal, as determined by FNSW, be met by the Respondent.</p>	

Aggrieved parties to a determination of the FNSW General Purposes Tribunal may lodge an appeal to the FNSW Appeals Tribunal in accordance with sections 8.8 and 9.2 of the FNSW Grievance and Disciplinary Regulations.
