<p><b>2.</b> The Respondent used offensive, insulting or abusive language and/or gestures against a Match Official in breach of section 15.4(d), Schedule 3, Table B, Number 1 of the Regulations.</p>	<p><b>2.</b> <u>Plea:</u> Guilty. <u>Finding:</u> Guilty <u>Determination:</u> <b>Three (3) Fixture suspension</b></p>
<p><b>3.</b> The Respondent failed to provide identifying details of an individual when reasonably requested to do so by a Match Official or Football</p>	<p><b>3.</b> <u>Plea:</u> Guilty. <u>Finding:</u> Guilty <u>Determination:</u> <b>Four (4) Fixture suspension</b></p>

<p>NSW employee or representative in breach of section 15.4(d), Schedule 3, Table C, Number 10 of the Regulations.</p>	<p><u>The sanctions in Charges 1, 2 and 3 are to be served partly concurrently such that the Respondent is only required to serve a total suspension of <b>Five (5) Fixtures</b>.</u></p> <p><u>NB. The Respondent is to serve the suspension as a Coach and in accordance with section 14.6 of the Regulations, in particular, sub-sections 14.6(h) and (i) which provide that, on the day of a Fixture, the Respondent must not:</u></p> <ul style="list-style-type: none"> <li>a. <u>enter the field of play (or court), its surrounds, the technical area, players race, dressing rooms or any other place within a stadium, venue, ground or Centre where players and/or officials are likely to assemble to prepare for a match;</u></li> <li>b. <u>be seated in an area in a stadium, venue, ground or Centre normally reserved for players and/or officials; and</u></li> <li>c. <u>in the case of coach, must not engage or attempt to engage a third party to relay coaching instructions.</u></li> </ul>
