During the match, Spectators from the Club ignited a flare in breach of Section 16.4(d), Schedule 3, Table C, Offence Code 25-02 of the Football NSW 2018 Grievance and Disciplinary Regulations (Regulations).	1. <u><i>Plea:</i></u> Guilty. <u><i>Finding:</i></u> Guilty <u><i>Determination:</i></u> Pay a fine to Football NSW of \$5,000. The payment of the fine is to be suspended for the duration of the 2018 season.
2. During the match, Spectators from the Club graffitied/damaged facilities at Illinden Sports Park in breach of Section 16.4(d), Schedule 3, Table C, Offence Code 18-02 of the Regulations.	2. <u><i>Plea:</i></u> Guilty. <u><i>Finding:</i></u> Guilty <u><i>Determination:</i></u> Pay a \$1,000 fine to Football NSW and pay for the costs of the following repair/replacement work to be conducted at Illinden Sports Centre: <ul style="list-style-type: none"> • the shade sail over the spectator section burned by the flare; • the graffitied seats in the spectator section below the burnt shade sail; • the graffitied bathroom; and

	<ul style="list-style-type: none"> the fence around the perimeter of Illinden Sports Centre.
<p>Summary of Sanction:</p> <p><u>The Club has accepted the proposed sanctions set out in the Notice of Charge issued by Football NSW; that is:</u></p> <ul style="list-style-type: none"> <u>Pay a fine to Football NSW of \$5,000. The payment of the fine is to be suspended for the duration of the 2018 season. If supporters of the Club are found to have committed a similar offence/s (ie, offences involving flares, incendiary devices or any offences involving Prohibited Items) during the remainder of the 2018 season (including the Championship, if applicable) then, in addition to any sanction imposed in respect of the fresh offence/s, the suspended part of the sanction in respect of Charge 1 will be activated and the Club will be required to pay the fine of \$5,000.</u> <u>Pay a \$1,000 fine to Football NSW and pay for the costs of the following repair/replacement work to be conducted at Illinden Sports Centre:</u> <ul style="list-style-type: none"> <u>the shade sail over the spectator section burned by the flare;</u> <u>the graffitied seats in the spectator section below the burnt shade sail;</u> <u>the graffitied bathroom; and</u> <u>the fence around the perimeter of Illinden Sports Centre.</u>
