2020 COMMUNITY FOOTBALL PLAYER REGISTRATION FEES

All fees and charges listed below are GST inclusive. The fees listed below relate to the package of services provided by Football NSW Limited.

Football4All Player Fees

Fees listed for players with disabilities are applicable only to players registered in a Football NSW approved Club or Association-based program operating as part of the Football NSW Football4All programs.

All Football4All programs operating within Football NSW must be approved by the local Football Association and by Football NSW.

Important Information

The Football NSW Capitation Fee represents the financial contribution registered participants make to Football NSW to enable it to provide a wide range of programs, benefits and services to them and to the broader football community.

In the past, Football NSW has had six categories of registration:

- 5 – 9;
- 10 – 11;
- 12 – 17;
- 18
- Senior (19+)
- Senior Student (19+)

This is now considered too specific, overly complicated and not aligned with the way FFA, other Member Federations categorise their players

Accordingly, the Football NSW Board has taken the decision to adjust its community registration fees to reduce the number of categories from six categories to three:

- 5 – 12;
- 13 – 18, and;
- 19+.

Football NSW is merging the two senior categories into one, meaning there will no longer be a different fee for players who indicate in PlayFootball that they are students. FFA does not offer a student rate, no other Member Federation and most Associations do not offer a student rate. However, there is nothing to prevent Associations or Clubs who wish to offer a student discount from continuing to do so.

Accordingly, Football NSW considers that it is better to merge the student and senior categories into one.

For Club and Association registrars, the result is that our fee structure is simpler and easier to understand, making it simpler to budget and set fees.

Schedule for Association Payments of Football NSW Fees

- Associations to pay 60% of the total payment by Tuesday, 30 April 2020 (the Tax Invoice for this 60% payment will be issued by Football NSW based on 2019 registration figures);
- Registration fees will be calculated based on PlayFootball data as at 30 June 2020;
- Registration data will be sent to Associations for confirmation by Wednesday, 8 July 2020;
- Confirmation of registration data to be returned to Football NSW by Friday, 24 July 2020;
- Football NSW will issue invoices within two business days upon receipt of confirmation of registration data; and
- Payment of the balance of the amount due to Football NSW is to be made within 30 days from the date of invoice.
