During Match One, a supporter of Western Sydney Wanderers FC (the Club) threw an object onto the Field of Play in breach of section 16.4(d), Schedule 3, Table C, Offence Code 23-01 of the FNSW Grievance and Disciplinary Regulations (Regulations).	1. <u><i>Plea:</i></u> Guilty. <u><i>Finding:</i></u> Guilty <u><i>Determination:</i></u> Pay a \$1,500 fine and a loss of three (3) Competition Points (loss of points to be suspended).
2. During Match One, supporters of the Club ignited a number of flares in breach of section 16.4(e) of the Regulations; namely section 2, subsection 3(c) and 3(d) of the Football NSW Stadium Technical Requirements 2017 Competitions and section 16.4(d), Schedule 3,	2. <u><i>Plea:</i></u> Guilty. <u><i>Finding:</i></u> Guilty <u><i>Determination:</i></u> Pay a \$1,000 fine and a loss of three (3) Competition Points (loss of points to be suspended).

During Match Two, supporters of the Club ignited a flare and threw it onto the Field of Play in breach of section 16.4(e) of the Regulations; namely: section 2, subsection 3(c) and 3(d) of the Football NSW Stadium Technical Requirements 2017 Competitions and section 16.4(d), Schedule 3, Table C, Offence Code 25-01 of the Regulations.</p>	<p>3. <u>Plea</u>: Guilty. <u>Finding</u>: Guilty</p> <p><u>Determination</u>:</p> <p>Pay a \$5,000 fine and a loss of six (6) Competition Points (loss of points to be suspended), as this is the second incident of the Club committing the offence of Schedule 3, Table C, Offence Code 25 of the Regulations.</p>
<p>Summary of Sanction:</p> <p>The Club has accepted the proposed sanction set out in the Notice of Charge issued by Football NSW; that is:</p> <ul style="list-style-type: none"> • A total fine of \$7,500. • The loss of 12 Competition Points (48 Club Championship Points) but suspended for the duration of the 2017 season (including the Championship, if applicable). <p>If supporters of the Club are found to have committed similar offences (ie, offences involving flares, incendiary devices or any offences involving Prohibited Items (see Section 2, Subsection 3 of the Football NSW Stadium Technical Requirements 2017 Competitions)) during the remainder of the 2017 season (including the Championship, if applicable) then, in addition to any sanction imposed in respect of the fresh offences, the suspended part of the sanction will be activated and the Club will incur a loss of 12 Competition Points (48 Club Championship Points).</p>
