Serving of Suspension:

The Respondent is required to serve the sanctions in Charges 1 and 2 wholly consecutively such that the Respondent will be required to serve a total suspension of four (4) Fixtures.

NB. The Respondent is to serve the suspension as a Player and in accordance with section 15.6 of the Regulations, in particular, sub-sections 15.6(h) and (j) which provide that, on the day of a Fixture, the Respondent must not:

- a. enter the field of play (or court), its surrounds, the technical area, players race, dressing rooms or any other place within a stadium, venue, ground or Centre where players and/or officials are likely to assemble to prepare for a match;*
- b. be seated in an area in a stadium, venue, ground or Centre normally reserved for players and/or officials; and*
- c. in the case of coach, must not engage or attempt to engage a third party to relay coaching instructions.*

This suspension would be served in the Respondent's next four Fixtures in the Competition he has registered in and in accordance with section 15.5 of the Regulations.
