Lucas Pervan (the <b>Respondent</b> ) participated in a melee in breach of section 16.4(d), Schedule 3, Table C, Offence Code 11-01 of the FNSW Grievance and Disciplinary Regulations ( <b>Regulations</b> ).	1. <u>Plea</u> : Guilty. <u>Finding</u> : Guilty <u>Determination</u> : <b>One (1) Month Suspension</b>
<p><b>Serving of Suspension:</b></p> <p>As the Participant is already subject to an eight (8) Fixture suspension in respect to a Red Card Offence committed during the same match, both the Red Card Offence and the current charge above are to be served partly concurrently such that the Respondent is required to serve a total Time Suspension from all Football Related Activity for <b>two (2) months (one (1) month of those to be suspended)</b>.</p> <p>The Participant is to serve the two (2) month Time Suspension in the following manner:</p> <ol style="list-style-type: none"> <li>I. the Participant is entitled to participate in the upcoming 2017/18 futsal season and in any summer football;</li> <li>II. the Participant is entitled to participate in trials and trial matches as part of the 2018 eleven-a-side pre-season; and</li> </ol>	

III. from Round One of the 2018 NPL Season (or the competition in which the Participant participates in 2018), the two (2) month Time Suspension is activated and the Participant is suspended from all Football Related Activities, as defined in section 15.5(e) of the Regulations, until he has served his two (2) month Time Suspension in full.

If the Respondent is found to have breached the Football NSW Grievance and Disciplinary Regulations during the 2018 season (or the competition in which the Respondent participates in 2018) then, in addition to any sanction imposed in respect of the fresh offence/s, the suspended part of the sanction (ie, the additional one (1) month of the Time Suspension) will be activated.
