Serving of Suspension:

The sanctions in Charges 1, 2 and 3 are to be served partly concurrently such that the Respondent is required to serve a total Time Suspension from all Football Related Activity for **two (2) months.**

The Participant is to serve the proposed Time Suspension in the following manner:

- I. the Participant is entitled to participate in the 2017/18 summer football season;
- II. the Participant is entitled to participate in trial matches as part of the 2018 eleven-a-side pre-season (including pre-season tournaments); and
- III. from Round One of the 2018 Central Coast Football competition in which the Participant participates in, the Time Suspension is activated and the Participant is suspended from all Football Related Activities, as defined in section 15.5(e) of the Regulations, until he has served his Time Suspension in full.
