## Charge(s) and Determination(s):

<b>Charge(s)</b>	<b>Determination</b>
1. Doron Pozniak (the <b>Respondent</b> ) was issued with an "R7" Red Card for receiving two Yellow Cards in a match in breach of section 16.4(d), Schedule 3, Table A, Red Card Code: R7, Offence Code 01-01 of the Football NSW 2018 Grievance and Disciplinary Regulations ( <b>Regulations</b> ).	<i><u>Plea:</u></i> Guilty. <i><u>Finding:</u></i> Guilty <i><u>Determination:</u></i> <b>One (1) Fixture suspension (Mandatory Match Suspension)</b>
2. The Respondent repeatedly and/or excessively used offensive, insulting or abusive language and/or gestures towards a match official, in breach of Section 16.4(d), Schedule 3, Table B, Offence Code 05-01 of the Regulations.	<i><u>Plea:</u></i> Guilty. <i><u>Finding:</u></i> Guilty <i><u>Determination:</u></i> <b>Time suspension for the entirety of the 2019/20 Football NSW Futsal Premier League season</b>
<b>Serving of Suspension:</b> <i>While the Respondent was issued with an "R7" Red Card and then committed a separate misconduct offence during the same match, the Respondent is to serve both suspensions concurrently.</i>	

*The start date of the Respondent's suspension is Round 1 of the 2019/20 Football NSW Futsal Premier League season and the end date is the final round of the Finals Series of that Competition.*

NB. For the avoidance of doubt, during his period of suspension, the Respondent is suspended from all Football Related Activities in accordance with section 15.5 of the Regulations, in particular, sub-section 15.5(e), which provides that the Respondent cannot participate in the following activities during the period of his suspension:

- a. taking to the Field of Play (or court) as a Player or Match Official in any match or competition sanctioned or administered by Football NSW, Clubs, Centres, Association Members or their clubs;
- b. taking a position as a coach, Team Official or Club Official in any match or competition sanctioned or administered by Football NSW, Clubs, Centres, Association Members or their clubs;
- c. entering the Field of Play (or court), its surrounds, the Technical Area, players race, dressing rooms or any other place within a venue on a match day where players, coaches or Officials are likely to assemble to prepare for a match;
- d. taking part as a player, coach, Team Official or Club Official in any training session conducted by or for a team or club participating in any matches or competitions sanctioned or administered by Football NSW, Clubs, Centres, Association Members or their clubs;
- e. acting in any way as a Team Official, Club Official or Association Member Official, including, but not limited to, participating in or carrying on any function as a member of a committee, sub-committee or board of directors (whether paid, voluntary or honorary) at any level (to the extent such a restraint is permissible by law);
- f. attending any function or event coordinated, conducted or sanctioned by Football NSW; and/or
- g. entering a stadium venue, ground or Centre during any match, competition or training session sanctioned or administered by Football NSW, Clubs, Centres, Association Members or their clubs.
