Halil Boz (the <b>Respondent</b> ) disputed a decision of a Match Official or dissent in breach of section 16.4(d), Schedule 3, Table B, Offence Code 02-01 of the FNSW Grievance and Disciplinary Regulations ( <b>Regulations</b> ).	1. <u>Plea</u> : Guilty. <u>Finding</u> : Guilty <u>Determination</u> : <b>One (1) Fixture suspension</b>
2. The Respondent failed to abide by or comply with a direction of a Match Official in breach of section 16.4(d), Schedule 3, Table B, Offence Code 01-01 of the Regulations.	2. <u>Plea</u> : Guilty. <u>Finding</u> : Guilty <u>Determination</u> : <b>One (1) Fixture suspension</b>
3. The Respondent used offensive, insulting or abusive language and/or gestures towards or at a Match Official (isolated incident) in breach of section 16.4(d), Schedule 3, Table B, Offence Code 04-01 of the Regulations.	3. <u>Plea</u> : Guilty. <u>Finding</u> : Guilty <u>Determination</u> : <b>Five (5) Fixture suspension</b>

**Serving of Suspension:**

The sanctions in Charges 1, 2 and 3 are to be served wholly concurrently such that the Respondent is required to serve a total suspension of **Five (5) Fixtures**.

NB. The Respondent is to serve the suspension as an Official and in accordance with section 15.6 of the Regulations, in particular, sub-sections 15.6(h) and (j) which provide that, on the day of a Fixture, the Respondent must not:

- a. enter the field of play (or court), its surrounds, the technical area, players race, dressing rooms or any other place within a stadium, venue, ground or Centre where players and/or officials are likely to assemble to prepare for a match;
- b. be seated in an area in a stadium, venue, ground or Centre normally reserved for players and/or officials; and
- c. in the case of coach, must not engage or attempt to engage a third party to relay coaching instructions.
