The Respondent is to serve the suspension as an Official and in accordance with section 15.6 of the Regulations, in particular, sub-sections 15.6(h) and (j) which provide that, on the day of a Fixture, the Respondent must not:</u></p> <ul style="list-style-type: none"> a. <u>enter the field of play (or court), its surrounds, the technical area, players race, dressing rooms or any other place within a stadium, venue, ground or Centre where players and/or officials are likely to assemble to prepare for a match;</u> b. <u>be seated in an area in a stadium, venue, ground or Centre normally reserved for players and/or officials; and</u> c. <u>in the case of coach, must not engage or attempt to engage a third party to relay coaching instructions.</u>
