2. The Respondent used offensive, insulting or abusive language and/or gestures towards or at a Match Official (isolated incident) in breach of section 16.4(d), Schedule 3, Table B, Offence Code 04-01 of the Regulations.	2. <u><i>Plea:</i></u> Guilty. <u><i>Finding:</i></u> Guilty <u><i>Determination:</i></u> <b>Five (5) Fixture suspension</b>
3. The Respondent failed to abide by or comply with a decision of a Match Official in breach of section 16.4(d), Schedule 3, Table B, Offence Code 01-01 of the Regulations.	3. <u><i>Plea:</i></u> Guilty. <u><i>Finding:</i></u> Guilty <u><i>Determination:</i></u> <b>One (1) Fixture suspension</b>

<p><b>Serving of Suspension:</b></p> <p><u>The sanctions in Charges 1, 2, 3 and 4 are to be served wholly concurrently such that the Respondent is required to serve a total suspension of <b>5 Fixtures</b>.</u></p> <p><u>NB. The Respondent is to serve the suspension as an Official and in accordance with section 15.6 of the Regulations, in particular, sub-sections 15.6(h) and (j) which provide that, on the day of a Fixture, the Respondent must not:</u></p> <ul style="list-style-type: none"> <li>a. <u>enter the field of play (or court), its surrounds, the technical area, players race, dressing rooms or any other place within a stadium, venue, ground or Centre where players and/or officials are likely to assemble to prepare for a match;</u></li> <li>b. <u>be seated in an area in a stadium, venue, ground or Centre normally reserved for players and/or officials; and</u></li> <li>c. <u>in the case of coach, must not engage or attempt to engage a third party to relay coaching instructions.</u></li> </ul>
