In or around September 2018, Football NSW imposed a sanction on the Respondent in respect of his actions on 16 June 2018 by banning him from attending, inter alia, any match in which SUFC were playing, by attending the Match in breach of the ban, Mr Pervan committed the offence set out in Schedule 3, Table C – Offence Code 27-01 of the Football NSW Grievance and Disciplinary Regulations 2021 (Regulations).</p>	<p>1. <u>Plea</u>: Guilty. <u>Finding</u>: Guilty <u>Determination</u>: Time Suspension of five (5) years</p>
<p>2. In or about the 8th minute of the Match, the Respondent engaged in conduct which included giving middle finger and open palm gestures to the RIFC supporters and then advanced through the crowd yelling at the RIFC supporters in breach of section 16.4(d), Schedule 3, Table C,</p>	<p>2. <u>Plea</u>: Guilty. <u>Finding</u>: Guilty <u>Determination</u>: Time Suspension of two (2) years</p>

<p>Offence Code 09-01 of the Regulations.</p>	
<p>3. At the conclusion of the Match, Mr Pervan engaged in serious violent conduct which included, but was not limited to, whipping supporters of RIFC with a doubled over belt in breach of section 16.4(d) Schedule 3, Table C, Offence Code 17-01 of the Regulations.</p>	<p>3. <u>Plea:</u> Guilty. <u>Finding:</u> Guilty <u>Determination:</u> Time Suspension of life.</p>
<p><u>Serving of Suspension:</u></p> <p>A Time Suspension effects a Participant's participation in both eleven-a-side football and futsal, regardless of whether the infringement was committed in an eleven-a-side football Match or in a futsal Match.</p> <p>A suspension from all Football Related Activities is to be served in accordance with section 15.5 of the Regulations, in particular 15.5(a), 15.5(d) and 15.5(e). The Term "Football Related Activities" has the meaning given to it in section 15.5(e) of the Regulations and includes:</p> <ul style="list-style-type: none"> i. taking to the Field of Play (or court) as a Player or Match Official in any Match or Competition sanctioned or administered by Football NSW, Clubs, Centres, Association Members, Branches, Regional Associations or their clubs; ii. taking a position or acting as a coach, Team Official or Club Official in any match or competition sanctioned or administered by Football NSW Clubs, Centres, Association Members, Branches, Regional Associations or their clubs (in the case of a coach, this includes providing or attempting to provide coaching instructions or engaging or attempting to engage a third party to relay coaching instructions); iii. entering the Field of Play (or court), its surrounds, the Technical Area, players race, dressing rooms or any other place within a venue on a match day where players coaches of Officials are likely to assemble to prepare for a match; iv. taking part as a player, coach, Team Official or Club Official in any training session conducted by or for a team or club participating in any matches or competitions sanctioned or administered by Football NSW, Clubs, Centres, Association Members, Branches, Regional Associations or their clubs; v. acting in any way as a Team Official, Club Official or Association Member Official, including, but not limited to, participating in or carrying on any function as a member of a committee, sub-committee or board of directors (whether paid, voluntary or honorary) at any level (to the extent such a restraint is permissible by law); vi. having any contact with the Host Broadcaster or any other media where the purpose of such contact is for it to be electronically broadcast to the public, including (but not 	

<p>limited to) participating in any post-match press conference and participating in television or radio interviews;</p> <p>vii. attending any function or even coordinated, conducted or sanctioned by Football NSW; and/or</p> <p>viii. Entering a stadium, venue, ground or Centre during any match, competition or training session sanctioned or administered by Football NSW, Clubs, Centres, Association Members, Branches, Regional Associations or their clubs.</p>
