This document constitutes a Preliminary Notice of Determination resulting from the Tribunal listed above and relating to charges against the Respondent under section 8.2 of Football NSW Regulations (Regulations) for alleged breaches by Mr Shane Duffy of sections 2.1, 2.2 (c) and/or (f) of the FFA Code of Conduct and/or sections 15.3(b), (d), (e) and/or (g) of the Football NSW Grievance and Disciplinary Regulations related to an incident with players and Match Officials at a Football NSW National Women's Premier League 2 (WNPL2) fixture between Southern Branch FC and Marconi Stallions on Sunday, 17 May 2015 at South Nowra Football Park.

Summation of the Tribunal:			
The Tribunal found that the evidence and admissions:			
Wholly supported the Charges brought against Mr Shane Duffy.			
Determination of the Tribunal:			
The Tribunal found that Mr Shane Duffy was guilty of all charges related to the relevant incidents.			
Sanctions Imposed			
The Tribunal imposed an eight (8) fixture suspension on Mr Shane Duffy from all Football related activities, including spectating. Two (2) fixtures of this suspension are waived due to Mr Duffy's guilty plea and clearly demonstrated remorse and understanding of his inappropriate behaviour.			
Marconi Stallions tendered evidence substantiating that Mr Duffy was suspended by his club from 26 May. His suspension is therefore is deemed to commence from that date.
