The Respondent is to serve the suspension as a Team Official and in accordance with section 14.6 of the Regulations, in particular, sub-sections 14.6(h) and (i) which provide that, on the day of a Fixture, the Respondent must not:</u></i></p> <ul style="list-style-type: none"> a. <i><u>enter the field of play (or court), its surrounds, the technical area, players race, dressing rooms or any other place within a stadium, venue, ground or Centre where players and/or officials are likely to assemble to prepare for a match;</u></i> b. <i><u>be seated in an area in a stadium, venue, ground or Centre normally reserved for players and/or officials; and</u></i> c. <i><u>in the case of coach, must not engage or attempt to engage a third party to relay coaching instructions.</u></i> <p><i><u>For the avoidance of doubt, the Respondent is able to conduct training sessions and coach during pre-season trial and friendly matches. However, such matches will not count towards the serving of the suspension.</u></i></p>
