## Summary of Sanction:

The Club has accepted the proposed sanctions set out in the Notice of Charge issued by Football NSW; that is:

- A total fine payable to Football NSW of \$16,750. The Club is only required to pay \$5,250 with the remaining \$11,500 to be suspended until the end of the 2020 season.
- The Club to be issued with a written warning from Football NSW for failing to follow the correct procedure with respect to deregistering its Players and registering Players with the Club's Technical Director's email address.
- The Player registered with the Club without an ITC is unable to participate until he receives an ITC.
- The Club forfeits 21 matches in which Ineligible Players participated.

• The loss of a total of 126 Club Championship Points. The Club will only lose 32 Club Championship Points with the remaining 94 points to be suspended until the end of the 2020 season.

If the Club is found to have committed the following offence/s (or similar):

- altering Players' dates of births;
- creating new MFC accounts for Players containing conflicting information;
- fraudulently deregistering Players from the Club via MFC;
- register Players within incorrect age groups; and
- allowing Players to participate in matches without an ITC,

during the remainder of the 2018 season, 2019 season and 2020 season (including the Championships, if applicable) then, in addition to any sanction imposed in respect of the fresh offence/s, the suspended parts of the sanctions in respect of this Notice of Charge will be activated and the Club will be required to pay the remaining fine of \$12,250 to Football NSW and will lose 94 Club Championship Points.
