Serving of Suspension:

The Respondent has agreed to the proposed sanction in the Notice of Charge, which is:

- serve a suspension of four (4) Fixtures; and

- undertake an on-line course called, “Let Kids be Kids” provided by “Play By The Rules” within two weeks from the date of accepting the proposed sanction in this Notice of Charge and provides Football NSW with proof of having completed the course. To access the course please [click here](#).

Please note the Respondent’s Club has issued the Respondent with a suspension of four (4) Fixtures and he has served part of this sanction. Any suspension already served by the Respondent will count toward the service of Football NSW’s sanction.

The Respondent is to serve the suspension as an Official and in accordance with section 15.6 of the Regulations, in particular, sub-sections 15.6(h) and (j) which provide that, on the day of a Fixture, the Respondent must not:

- a. enter the field of play (or court), its surrounds, the technical area, players race, dressing rooms or any other place within a stadium, venue, ground or Centre where players and/or officials are likely to assemble to prepare for a match;*
- b. be seated in an area in a stadium, venue, ground or Centre normally reserved for players and/or officials; and*
- c. in the case of coach, must not provide or attempt to provide coaching instructions or engage or attempt to engage a third party to relay coaching instructions.*

The Club and Club Officials are responsible for ensuring the Respondent correctly and fully serves any Suspension.

The Club and Club Officials must list in an appropriate place on a team sheet that the Respondent is serving a Suspension at the time the team sheet is completed.

Failure to do so will result in a fine of \$200 per Participant per match and further sanctions.
