

# PRELIMINARY NOTICE OF DETERMINATION. 27<sup>th</sup> November 2018

This document constitutes a Preliminary Notice of Determination resulting from the Tribunal listed above.

Charges against the **Respondent** under Sections 9.2 and 16.4(d) of Football NSW Grievance and Disciplinary Regulations 2018 for alleged breaches of the Regulations and the FFA Code of Conduct related to incidents during the Futsal Premier Leagues 2 (**FPL2**) 19 Men's match between West City Crusaders FC and Sydney City Eagles on 3 November 2018 at Hawkesbury Indoor Stadium.

#### **Summation of the Tribunal:**

The Tribunal found that the evidence and admissions:

**In part supported the Charges** brought against the Respondent.

## **Determination of the Tribunal:**

### Charge 1:

During the Futsal Premier Leagues 2 (**FPL2**) 19 Men's match between West City Crusaders FC and Sydney City Eagles on 3 November 2018 at Hawkesbury Indoor Stadium, Jesse Boness of West City Crusaders FC (the **Respondent**) punched an opposition player (Martin Fernandez) in the face with excessive force.

### Charge 2:

The Respondent then participated in a melee.

#### Charge 3:

After the Respondent was sent off by a Match Official, the Respondent kicked a chair in the Technical Area and said *"That's fucking bullshit"* to a Match Official (Jamie Ewin).

In relation to Charge 1 the Respondent pleaded NOT GUILTY to the Charge. The Respondent did not address Charges 2 and 3 in his Notice of Response however pleaded Not Guilty at the Hearing.

The Tribunal found that:

- A. The Respondent was Guilty of Charge 1.
- B. The Respondent was Not Guilty of Charge 2.
- C. The Respondent was Guilty of Charge 3.
- D. There was inconsistency in the evidence available from the Referees. One Referee noted that Mr O'Riley, the co-Respondent, kicked a chair whilst the other two did not. One Referee noted that it was the Respondent who kicked the chair albeit that he was not charged with that offence.
- E. The Referees stated that the alleged "melee" took 5-10 seconds.
- F. Evidence from the co-accused, from Sydney City Eagles, was consistent with the Referee's reports in relation to the punches.
- G. The Respondent did involve himself in a fight and was correctly issued with a Red Card for his involvement in the fight.
- H. The Tribunal found that there was no melee as alleged.

| Sanctions Imposed  |      |  |

| Charge 1: The Tribunal preferred a Sanction under Schedule 3, Table A R2, Violent Conduct, Grading 02-01. The Tribunal imposes a suspension of seven (7) Fixtures. The Respondent was the instigator of the incident and failed to plead guilty even when given an opportunity to do so at the Hearing.  |      |  |
| Charge 2: The Tribunal found that there was no melee as alleged and therefore the Respondent was Not Guilty under this Charge.   |      |  |
| Charge 3: The Respondent admitted that he said "that's bullshit" to the Referee but denied using the intervening swear word. This outburst clearly represents dissent by word or action, with or without the expletive, and an offence under Schedule 3, Table B R6, Grading 02-01. A suspension of two (2) Fixtures was imposed.  As the above Charges relate to separate incidents, the Respondent is to serve these suspensions consecutively. The Respondent has now served a three (3) Fixture suspension, he is therefore to serve an additional six (6) Fixture suspension. |      |  |
