<p>In relation to Charges 1 and 2, the loss of points is suspended and will be activated should a supporter of the Respondent be found guilty of a similar incident (i.e. throwing a missile onto the Field of Play) during the remainder of the 2019 season. For clarity, the loss of points will be in addition to any sanction imposed in respect of the fresh offence/s.</p> <p>In relation to Charges 3 and 4, this Notice of Determination counts as a formal warning. Should a supporter of the Respondent be found guilty of a similar incident (i.e. a pitch invasion) for a second time during the remainder of the 2019 season, the Respondent will be issued with a fine of at least \$5,000. Should a supporter of the Respondent be found guilty of a similar incident (i.e. a pitch invasion) for a third or subsequent time during the remainder of the 2019 season, the Respondent will be issued with a fine of at least \$5,000 and will lose at least six (6) Competition Points (24 Club Championship Points). For clarity, the loss of points will not be suspended and the loss of points will be applied immediately.</p>
