

### Serving of Suspension:

<u>The sanctions in Charges 1 and 2 are to be served wholly concurrently such that the</u> <u>Respondent is required to serve a 24 month Time Suspension.</u>

<u>NB. For the avoidance of doubt, the Respondent is suspended from All Football Related</u> <u>Activities in accordance with section 15.5 of the Regulations, in particular, sub-sections</u> <u>15.5(a) and (d), which provides that the Respondent cannot participate in the following</u> <u>activities:</u>

- *i.* <u>taking to the Field of Play (or court) as a Player or Match Official in any match or</u> <u>competition sanctioned or administered by Football NSW, Clubs, Centres,</u> <u>Association Members or their clubs;</u>
- ii. <u>taking a position as a coach, Team Official or Club Official in any match or</u> <u>competition sanctioned or administered by Football NSW, Clubs, Centres,</u> <u>Association Members or their clubs;</u>
- iii. <u>entering the Field of Play (or court), its surrounds, the Technical Area, players</u> <u>race, dressing rooms or any other place within a venue on a match day where</u> <u>players, coaches or Officials are likely to assemble to prepare for a match;</u>
- iv. <u>taking part as a player, coach, Team Official or Club Official in any training</u> <u>session conducted by or for a team or club participating in any matches or</u> <u>competitions sanctioned or administered by Football NSW, Clubs, Centres,</u> <u>Association Members or their clubs;</u>
- acting in any way as a Team Official, Club Official or Association Member Official, including, but not limited to, participating in or carrying on any function as a member of a committee, sub-committee or board of directors (whether paid, voluntary or honorary) at any level (to the extent such a restraint is permissible by law);
- vi. <u>attending any function or event coordinated, conducted or sanctioned by Football</u> <u>NSW; and/or</u>
- vii. <u>entering a stadium venue, ground or Centre during any match, competition or</u> <u>training session sanctioned or administered by Football NSW, Clubs, Centres,</u> <u>Association Members or their clubs.</u>
