

#### PRELIMINARY NOTICE OF DETERMINATION.

This document constitutes a Preliminary Notice of Determination resulting from the Tribunal listed above.

Charges against the Respondent under section 9.2 and 16.4 of Football NSW Regulations (Regulations) for alleged breaches by the Respondent of sections 16.4(d) of the Football NSW Grievance and Disciplinary Regulations related to incidents during the National Premier League 3 (NPL3) 1st grade match between St George City FA and SD Raiders FC at Fraser Park on 18 March 2017.

Summation of the Tribunal:	

The Tribunal found that the evidence and admissions:

Did not support the Charge brought against the Respondent.

## **Determination of the Tribunal:**

The Respondent pleaded NOT GUILTY to the Charge.

The Tribunal found the Respondent NOT GUILTY of the Charge.

## **Sanctions Imposed**

The Tribunal heard evidence from both SD players, Damien Smith and Mirza Sehic. The evidence of both these players when examined in conjunction was conflicting to such a level that the panel had very serious concerns in relation to the truthfulness of the evidence presented by both these witnesses.

The most concerning example of this lack of consistency in the evidence of both these witnesses is that Mr Smith, who gave evidence first, stated that he heard the threat allegedly said by Mr Jovovic. Mr Sehic then gave evidence that the threat was made by Mr Jovovic in the Serbian language. There was no mention of this threat being in any language other than English by Mr Smith, who presumably does not understand the Serbian language. There was nothing in any of the written evidence tendered in relation to this charge that mentioned anything about the threat being in any language other than English.

Furthermore, the lack of further corroborating evidence from anybody else of a threat that was allegedly made in the middle of a melee was also a cause of concern for the Tribunal. Accordingly, the charge against Mr Jovovic is also dismissed.
