

## PRELIMINARY NOTICE OF DETERMINATION.

This document constitutes a Preliminary Notice of Determination resulting from the Tribunal listed above.

Charges against the Respondent under section 9.2 and 16.4 of Football NSW Regulations (Regulations) for alleged breaches by the Respondent of sections 16.4(d), (f) and/or (g) of the Football NSW Grievance and Disciplinary Regulations related to incidents during the National Premier League 3 1st grade match between Gladesville Ryde Magic FC and Dunbar Rovers FC at Magdala Park on 9 April 2017.

Summation of the Tribunal:		
The Tribunal found that the evidence and admissions:		
Supported the Charges brought against the Respondent.		
Determination of the Tribunal:		
The Respondent pleaded NOT GUILTY to Charge 1.		
The Tribunal found the Respondent GUILTY of Charge 1.		
Sanctions Imposed		
In relation to Charge 1, the Tribunal imposed sanctions on the Respondent under Schedule 3, Table C, Numbers 3 and 7 – Other Offences by Members: "Conduct which brings or may bring the game into Disrepute or damage the reputation and goodwill of the game", and "Unsportsmanlike or unprofessional behaviour".		
The Respondent is suspended for <b>three (3) fixtures</b> from all football related activities in relation to the Charge 1 to be served in accordance with Section 15 of the Regulations and in particular 15.6(h).		
The Tribunal found that the Respondent was acting in the capacity of President and Official of his Club and therefore he is to serve his suspension by absenting himself from all Fixtures of the Club until 3 Fixtures have been played by the Gladesville Ryde Magic FC 1 <sup>st</sup> grade in the National Premier League 3.		
This Sanction is to commence immediately.		
Fines Imposed	NIL.	
Bonds Imposed	Nil.	

## Additional Matters and Fees as per the Notice of Costs:

The Respondent is to pay the costs of the Tribunal process as assessed by Football NSW.

A full written Determination will be produced.

Aggrieved parties to a determination of the FNSW General Purposes Tribunal may lodge an appeal to the FNSW Appeals Tribunal in accordance with sections 9.6 and 10 of the FNSW Grievance and Disciplinary Regulations.
