- The immediate loss of six (6) Competition Points (24 Club Championship Points) and
- The loss of three (3) Competition Points (12 Club Championship Points) but **suspended** for the duration of the 2017 season (including the Championship, if applicable).

If supporters of the Club are found to have committed a similar offence/s (ie, offences involving spitting, using offensive language or violent behaviour) during the remainder of the 2017 season (including the Championship, if applicable) then, in addition to any sanction imposed in respect of the fresh offence/s, the suspended part of the sanction will be activated and the Club will incur a further loss of three Competition Points (12 Club Championship Points).
