<p><i>NB. The Respondent is to serve the suspension as a Spectator and in accordance with section 15.6 of the Regulations, in particular, sub-section 15.6(k) which provides that, on the day of a Fixture, the Respondent must not enter a stadium, venue, ground or Centre during a Fixture until that Suspension is served in full.</i></p> <p><i>For the avoidance of doubt, this means that the Respondent will must not attend any of the Club's matches until the suspension is served in full even if he would be attending in his capacity as a Team Official.</i></p> <p><u>The following specifications are applied:</u></p> <ul style="list-style-type: none"><i>The participant subject to a Fixture Suspension resulting from or related to any Trial Match, the NPL Pre-Season Competition or any other Tournament must serve that suspension in the next consecutive Trial Match, NPL Pre-Season Competition, Tournament, Premiership, Championship, Cup or FFA Cup Match/Fixture in which the</i>	

Participant's Team or Club plays in, whichever occurs first.

- *In accordance with section 15.3 of the Regulation, the Club and Club Officials are responsible for ensuring the Respondent correctly and fully serves any Suspension.*
- *A Club and/or Club Official in breach of section 15.3 will be deemed to have committed Misconduct (section 16.4) and the Executive may, in its absolute discretion, take any relevant action pursuant to section 9.2*
- NB. The Respondent is entitled to attend and conduct training sessions with his or any other team.
