Registration process

All players participating in an approved Local Futsal Affiliated competition must be registered to a team in the relevant competition online through the prescribed online registration system.

In addition to providing helpdesk support, FNSW issues registration guidelines to assist competitions operators and participants to navigate the online registration process. If you require assistance in creating and setting up packages withing PlayFootball our Online Service can assist through the process.

Counting/Billing Process

Deregistration Deadline:

We have set a Deregistration Deadline of 14 days after the date the competitions are due to start or 14 days after the player's registration (whichever is later) – if a player's deregistration is completed on or prior to the latter of 14 day after the date the competitions are due to start or within 14 days of their initial registration application, we will not count them in their centre's billing total. The competition start date will be as per the affiliation form submitted by the centre.

Final Census Date:

We will take the competition end date to be the Final Census Date. The competition end date will be as per the affiliation form submitted by the centre.

Counting process:

The counting process for our final player census will be as follows:

1. We will count all Registered players.

2. We will count all Deregistered players whose date of deregistration is later than the Deregistration Deadline.

3. We will count all players whose registration is Pending as at the Final Census Date. We will issue guidance to clubs to ensure that they either approve or decline any pending registrations to ensure that they are accurately billed.

In order to ensure that we do not bill multiple times for any one player at any given centre, we only bill the first billable registration for any player (i.e. that with the first registration date) for each centre.

Registration invoices

Period 1 Invoice:

Centres will be invoiced for an amount players' registration fees (active & pending) for the first 6 months of competition dates (July 23 - December 23)

Final Invoice:

Centres will be invoiced for an amount players' registration fees (active & pending) for the second 6 months of competition dates (January 24 – June 24)

Our second period will be the Final Census Date to complete the calendar year.
