Social Football 2024/25 Player Registration Fees

| Summer 2024/25 and Winter 2025 Social Football Registration Fees (GST Inclusive) | | | |

| Junior | \$2.57 | \$5.43 | \$8.00 |
| Senior | \$9.18 | \$18.82 | \$28.00 |

- Junior players are those turning up to 18 by 31st December in the calendar year in which the season commences (2024 for Summer 2024/25, 2025 for Winter 2025)
- Senior players are those turning 19 and above by 31st December in the calendar year in which the season commences (2024 for Summer 2024/25, 2025 for Winter 2025)
- Registration fees are inclusive of all levies and insurance policies.
- Players are **only** covered by the Football NSW Insurance Program if they are already registered at time of injury. Players who are **not** registered may have their claims denied.
- Social Football means small-sided (e.g.; 4v4, 5v5, 6v6, 7v7) modified games, including Walking Football
- **Football NSW Member Associations** can apply to conduct social football competitions in winter alongside their existing club football competitions

Registration and Competition periods

The registration and competition periods for the **Summer Football Season** are as follows:

- Registrations open July 2024
- Competitions commence no earlier than 1 September 2024
- Competitions conclude no later than 31 March 2025

The registration and competition periods for the **Winter Social Football Season** is as follows:

- Registrations open January 2025
- Competitions commence no earlier than 1 March 2025
- Competitions conclude no later than 30 September 2025

Registration process

All players participating in an approved Social Football competition must be registered to the relevant competition online through the prescribed online registration system.

In addition to providing helpdesk support, FNSW issues registration guidelines to assist competition operators and participants to navigate the online registration process.

Counting/Billing Process

Deregistration Deadline:

We have set a Deregistration Deadline of 14 days after the date the competitions are due to start – if a player's deregistration is completed on or prior to the Deregistration Deadline, we will not count them in their centre's billing total.

The competition start date will be as per the affiliation form submitted by the centre.

Census Date:

We will take the end of the Competition Period (30 September for Winter and 31 March for Summer) to be the Census Date.

Counting process:

The counting process for our final player census will be as follows:

1. We will count all Registered players.
2. We will count all Deregistered players whose date of deregistration is later than the Deregistration Deadline.
3. We will count all players whose registration is Pending as at the Census Date. We will issue guidance to clubs to ensure that they either approve or decline any pending registrations to ensure that they are accurately billed.
4. For **Winter Social Football only**, we will exclude from counting any player who is already registered for Winter Club Football.

In order to ensure that we do not bill multiple times for any one player at any given centre, we only bill the last billable registration for any player (i.e., that with the latest registration date) for each centre for each season (i.e., summer/winter). If a player plays at multiple centres or for multiple seasons, they will be counted for billing multiple times.

Registration invoices

Centres will be invoiced for players' registration fees on per-Season basis – one following the Winter Season and one following the Summer Season.
